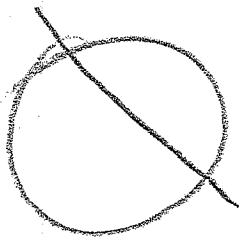

On May 5, 1975 Supervisor LYNDAL L. SHANEYFELT of FBIHQ telephonically advised he and a Bureau photographer would be arriving Dallas on Tuesday, May 6, 1975, to conduct some on-the-scene examinations. SA SHANEYFELT stated the presence of SA ROBERT P. GEMBERLING would not be necessary. He requested the following:

1. Contact Dallas Police Officers BILL BASS, MARVIN WISE, and ROY VAUGHN and ascertain their exact height on 11/22/63. At the same time ascertain the exact location where these officers found the 3 men on the boxcar in the railroad terminal area. It has been said it was about one mile from the assassination site.
2. SA SHANEYFELT desires two single rooms close to the office for Tuesday and possibly Wednesday nights. He will advise Supervisor JOHN K. HOFFMAN when he knows his arrival time.
