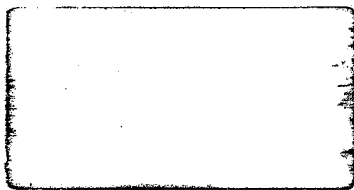

1. There was a mis spelling of the word shots that occurred twice in the statement.
2. Joe Lorraine was not with the School Book Depository, but was employed by The State Labor Board (Texas).
3. When I referred to the 5th floor, I was really talking about the 6th floor of The Texas School Book Depository.
4. There were boxes stacked up, making a cubby hole around the first window near the corner of the 6th floor floor of The School Book Depository. He saw some chicken bones and 3 rifle cartridges that had been fired.
