Interview:

Interviewed Mr. and Mrs. Bowers with a view of expanding existing W.C. & F.B.I. information given by their son before he sustained fatal injuries in a traffic accident three years ago.

Described their son as reticent by nature and protective insofar as his family was concerned (he had a wife and daughter). Consequently he told them practically nothing of his experiences on 11-22-63 other than to concede that he was on duty in "The Tower" when the assassination occurred. He mentioned the less others thought they knew the less problems they would have. Also added they were aware of the mouting toll of deaths of "Kennedy witnesses."

Mrs. Bowers asked for her son's statements (W.C. & F.B.I.) which she was given and proceeded to read each aloud-word for word-for the edification of her husband and gave us the impression neither han heard these details before.

Asked if the widow and/or daughter were available, Mrs. Bowers advised she would contact her daughter-in-law and inquire. Declined to give any detailed information other than to mention they are no concer in the Dallas area.

LONGER

We left our cards and the notice that we would make ourselves available if the balance of the family had any pertinent information.

Mrs. Bowers then informed us that "Lee would have told his brother if he told anyone, but added that he had since succumbed to cancer. The brother died first at the age of 40 and later Lee at 41.

Mr. Bowers, while cordial, contributed nothing significant to the interview.
